Vision for the Indian Ocean Region: Strategic Development Plan 2023-2033



Make the Indian Ocean Region a model of resilience and sustainability.

- Strengthen the sustainable management of ecosystems and the protection of unique biodiversity.
- Commit to tangible actions linked to climate change, security, and peace.



Promote innovative economic integration.

- Foster the development of regional value chains (tourism, fishing, agriculture, blue economy, and digital economy).
- Enhance digital, maritime, and air connectivity between the islands and the world.



Enhance well-being and inclusivity.

- Prioritize education, health, culture, and youth mobility.
- Promote gender equality and support the empowerment of vulnerable groups.



Strengthen the institutional and partnership framework.

- Modernize governance tools and processes.
- Develop new partnerships with international organizations and observer states for expanded cooperation.

A diversified and results-driven action.

Environment and climate

- A network of Marine Protected Areas (MPAs) established.
- A regional Integrated Coastal Zone Management (ICZM) protocol initiated by the IOC and adopted by the Nairobi Convention in 2023.
- The first regional report on the health status of coral reefs produced in 2018.
- Local initiatives for integrated management of marine and coastal environments (mangroves, marine parks, seagrasses, etc.).
- Networks of scientists and practitioners set up and supported on coral reefs, marine fauna, and coastal ecosystems.
- Equipment and training provided to national meteorological services, with continuous support for organizing Regional Seasonal Forecast Forums.
- Support for the African Island States Climate Commission and the negotiators of member states in preparation for the UN climate conferences (COPs).

Results: Enhanced knowledge, information sharing, and best practices contributing to biodiversity preservation, sustained climate advocacy, and the implementation of risk prevention and reduction actions.

Health

- A regional health cooperation network established in 2009 (the SEGA – One Health network).
- A regional health security strategy adopted in 2023.
- 273 trained field epidemiologists.
- Regular training sessions organized, and surveillance, diagnostic, and treatment equipment provided to human and animal health services, as well as to more than 40 laboratories.

Results : Strengthened health information sharing, improved surveillance, preparedness, diagnostics, and response to epidemic risks.

Digital Economy

- Support for the structuring and development of the region's most powerful digital cable project, METISS, led by six telecommunications operators from Mauritius (Emtel & CEBFiberNet), Réunion (Canal+, SFR, and ZEOP), and Madagascar (Telma).

Results : Improved digital connectivity with enhanced and secure internet access, and the deployment of new technologies (5G).

Maritime Security

- A maritime security architecture deployed.
- Strategic infrastructures established: a Regional Maritime Information Fusion Center (RMIFC) responsible for analyzing and sharing critical data on vessel movements, and a Regional Coordination Center for Operations (RCOC) dedicated to organizing maritime actions.
- Regional patrols organized, resulting in the rescue of tens of sailors, the seizure of over 3 tons of drugs, and a reduction in maritime crime risks in 2023-2024.
- Three maritime pollution simulation exercises held in Madagascar, Mauritius, and Kenya, along with a dozen tabletop exercises since 2020.

Results : Enhanced capabilities for surveillance, control, and suppression of maritime crimes and incidents (pollution, drug trafficking, etc.).

Fisheries and food security

- Implementation of a seasonal octopus (ourites) fishing ban in Rodrigues in 2012. The initiative has been replicated.
- 175,000 tuna tagged and over 30,000 recaptures, leading to a better understanding of fish stocks and the establishment of quotas for responsible fishing.
- Support for local environmentally-friendly agri-food production initiatives, awareness campaigns on nutrition, and assistance provided to agricultural laboratories in member states (seeds, equipment, etc.).

Results : Increased resources, revenues, and exports, with strengthened food security.

Entrepreneurship

- A boost and ongoing relationship with private sector associations: Cap Business océan Indien, Association of Ports of the Indian Ocean Islands, Vanilla Islands Association, Women Entrepreneurs of the Indian Ocean, Junior Chamber International, Synergie Jeune, and more.
- Support for around ten regional entrepreneurship competitions and forums.
- A circular economy action plan developed for the African Island States.
- 57 economic operators, including 34 women, supported to participate in international trade fairs on seafood in South Africa, cosmetics in France, and tourism in Greece in 2024.
- 243 beneficiaries of entrepreneurship training, including 108 women, in 2024.

Results : Economic operators networked, with a focus on youth, women, and the circular economy.

Culture

- A literary prize recognizing regional talent (already 3 award-winning and published novels).
- 125 grants awarded in 2024 to support creation, cultural events, mobility, and the professionalization of cultural operators.
- 40 podcast episodes produced to highlight cultural heritage.
- A platform created: Kiltir.org, a website offering news, opportunities, calendars, and thematic resources for cultural operators.

Results : Cultural heritage and regional talent are showcased.
